

## EARTHWORK TECHNICIAN CERTIFICATION EXPERIENCE FORM

In order to be certified by the SCDOT as an Earthwork/Base Technician, an individual needs to have a minimum level of familiarity and experience with the related test procedures, forms, specifications, and general operations. The signature on this form attests that the individual has **demonstrated** to a certified Earthwork/Base Technician (hereafter referred to as the "Rater") his/her experience in the areas indicated. <u>This form must be submitted at least one (1) month prior to the class</u>. <u>Applicants without the appropriate completed</u> <u>experience form submitted by the deadline will have their class space forfeited</u>. - **I.** General information for determining Earthwork/Base Applicant's qualification:
  - 1. Familiar with SCDOT specifications and special provisions concerning soils and earthwork construction and materials.
  - Ability to identify unusual conditions encountered in grading operations.
  - 3. Knowledge of drainage construction and pipe installation.
    - 4. Knowledge of sampling procedures for soil pits.
      - 5. Knowledge of grading and compaction equipment and procedures including calculations to determine compaction.
    - 6. Ability to determine depth and check cross-slope of subgrade, subbase or base by use of hand or eye level and to check grade.
  - 7. Knowledge of base construction operations to include mixing and shaping and base plant operations when applicable.
    - Ability to calculate the rate of application of cement, aggregate, primecoat and other similar materials.
    - 9. Ability to keep appropriate records and make accurate measurements to include excavation.
    - 10. Ability to determine the suitability of embankment and subgrade by proof rolling.
- II. Applicant has six months minimum related experience in Earthwork and Base Course construction and testing which includes SC-T-1, SC-T-2, SC-T-29, and SC-T-31.
