Please explain how these funds will be used to provide a public benefit:

As the fastest-growing county in one of the fastest growing states, Horry County has needs for new roads and upgrades to existing infrastructure that exceed our current financial resources. One of our critical needs is in the Carolina Forest Community to provide alternative ingress and egress to Carolina Bays Parkway (Hwy 31) from both River Oaks Drive and Carolina Forest Boulevard. Carolina Forest currently only has two points of access, including Highway 501 to the west ad SC 31 and Robert Grissom Boulevard to the East. These Intersections are heavily congested, presenting challenges to both public safety and the quality of life. A new interchange along Carolina Bays Parkway (SC 31) connecting Augusta Plantation to Revolutionary War Way is planned to alleviate these challenges by allowing people to easily access SC 31. Additional funding is needed for the engineering and construction of this critical infrastructure project.
