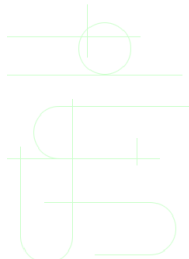
If that's the case, I assume the bridge is already back open/repared thus this earmark wouldn't have future expenditures as it's simply replacing money already spent. Is that accurate?
